MEMORANDUM OF UNDERSTANDING (MOU)

In order to promote cooperation between School of Social Work, Roshni Nilaya, affiliated to Mangalore University, India and Volda University College, Norway, the two institutions agree as follows:

To strengthen and develop the cooperation between our two institutions. We wish to enter into an agreement with School of Social Work, Roshni Nilaya, Mangalore and the faculty of Social Sciences in Volda.

Within fields that are mutually acceptable, the following general forms of cooperation will be pursued:

- Staff and students for study and research.
- Study abroad programmes.
- Student exchange programmes.
- Visits by and interchange of staff for research, teaching and discussions.
- Exchange of information including, but not limited to, exchange of library resources and research publications.
- Collaborative research activities.

Both parties understand that all financial arrangements will have to be negotiated and agreed upon with due regard to the availability of funds and other resources.

Specific details for the implementation of these activities will be developed mutually for specific projects.

The Memorandum of Understanding envisages that there will be a specific subsidiary contract for each particular project.

Nothing in this MOU shall prevent the Volda University College from making any special provision to utilize the expertise and resources available at other institutions in the Mangalore University area.

The duration of the MOU shall be five years from the date of signature. If the Memorandum of Understanding remains dormant for five consecutive years, it will be deemed to have lapsed. Where it continues to be active the two institutions shall review the arrangement six months prior to the expiry date. If the parties are agreeable, then the agreement shall be extended in writing for such period as may be agreed upon. The MOU may be terminated at any time by mutual written consent or by nine months' notice in writing by either of the two parties with due regard to the contractual commitments in terms of specific contracts.
