



MEMORANDUM OF UNDERSTANDING

BETWEEN

Inchara Foundation, a Non Profit Organisation, having its office at #7, Basement, MN Towers, Kadri, Mangalore-2, the Second Part, represented by Mr. Preetham Rodrigues, Director, Inchara Foundation.

AND

Sociology Economics Forum, School of Social Work, Roshi Nilaya, Mangalore, Mangalore, the First Part, represented by, Ms. Cecilia F. Goveas, Convenor, Sociology Economics Forum.

WHEREAS:

1. INCHARA FOUNDATION is *inter alia* engaged in the field of providing services in social services & development activities
2. INCHARA FOUNDATION has represented to **SOCIOLOGY ECONOMICS FORUM** about their ability and experience in providing services related to extension activities for the Forum. **SOCIOLOGY ECONOMICS FORUM** has expressed its willingness to engage INCHARA FOUNDATION to develop customized activities in but not limited to Child Safety with reference to prevention of Child Sexual Abuse. Project Angel is an initiative by Inchara Foundation for prevention of child sexual abuse.

NOW THIS AGREEMENT WITNESSES AND IT IS HEREBY AGREED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS

1. Definitions and Interpretations

Following terms when used in this Agreement shall have the following meanings:

- (a) **"Agreement"** means this Agreement and all annexures, supplements, appendices and modifications thereof.
- (b) **"Services"** means those specified in Clause 2 required to be provided by INCHARA FOUNDATION to SOCIOLOGY ECONOMICS FORUM. on an ongoing basis for the entire term of this Agreement.
- (c) **"Customized Activities"** means activities developed as per request and suggestions provided by Sociology Economics Forum
- (d) **"Term"** means the period commencing from 1st January 2016 till further termination by mutual consent



2. **Scope of services**

INCHARA FOUNDATION shall provide the services as mentioned below

- a. Implement "Project Angel" activities
- b. Plan and implement extension service activities for the Forum
- c. Involve faculty and students in all the programs
- d. Conduct workshops on child safety in communities and nearby schools
- e. Conduct exhibitions, seminar and workshops in collaboration
- f. Conduct life skills and soft skills trainings for the forum students
- g. Any other activities suggested by the forum within the scope of Inchara Foundation

3. **Quality and Specifications**

INCHARA FOUNDATION hereby undertakes that it shall take all necessary measures to ensure that the services rendered by it are of quality specifications or functionality parameters as specified herein or communicated by **SOCIOLOGY ECONOMICS FORUM** and agreed upon by **SOCIOLOGY ECONOMICS FORUM** from time to time.

4. **Payment terms**

As per mutually agreed terms and not legally binding

5. **Representations and Warranties**

The parties hereby represent and warrant that:

- (a) Each of them has full power and authority to carry on its business / profession;
- (b) The execution and delivery of this Agreement has been duly authorized by the authorized signatory (ies)

6. **Confidentiality**

In consideration of the benefit accruing to INCHARA FOUNDATION from its association under this Agreement, INCHARA FOUNDATION hereto agrees:



- (a) that it shall not, without the prior permission of the **SOCIOLOGY ECONOMICS FORUM**, directly or indirectly disclose or cause to be disclosed any Confidential Information to any third party and where such permission has been granted, **SOCIOLOGY ECONOMICS FORUM** shall execute appropriate written compliances with each such third party(ies) as if they are a party to this agreement and shall be liable for any failure to do so;

7. Term and Termination

This Agreement shall come into force w.e.f. 1st January 2016 and shall continue to be in force until mutually terminated

Provisions of this agreement shall supersede all the other documents or communication made between the parties before the date of execution of this Agreement.
